

Scratch 'N' Win 2024 Terms and Conditions

1. Entrants

2.1 To participate in Scratch 'N' Win, app users must **download** an up-to-date version of the **Bubble CiTea's app** on to a compatible device and **register** for a Bubble CiTea's app account

2.2 App Users must make **an instore purchase** at any Bubble CiTea's location between **15th-30th April 2024. A minimum requirement on the purchase is £10** (any item such as drinks, merch and snacks sold in Bubble CiTea's store are included)

2.3 Any app users who make an in-store purchase of a minimum of £10 between April 15th and April 30th, 2024, will be **automatically entered** into the **Scratch 'N' Win** campaign.
